

On the Cosmic Threshold

The great writer Thomas Mann observed in his novel, *The Magic Mountain*, that when our days are empty, they seem to drag on and on. But when we look back at our lives, we don't know where the years went. However, when our days are full, they seem to pass in the blink of an eye. When we look back at our lives, the years seem to have gone by slowly and to be rich and full.

That's how it feels to us when we look back at the Cosmos and Consciousness conferences—they

appear as a slowly unfolding pageant, moving toward a deeper understanding of ourselves and our place in the Universe. We have felt guided in this work by the primordial, physical cosmic force called Love.

In our first conference in 2003, the late Dr. John E. Mack spoke about the role of worldviews in determining "reality" at any given time, that is, what individuals and cultures believe is possible or impossible; real or not real.

There is truth in the expression "Seeing is believing." But there is just as much truth in the expression "Believing is seeing." Our worldviews determine what we see and what we do not see; what we believe and do not believe. At times, our worldviews help us make sense of existence. But, at other times, they lead us to believe in things that are not true, and also, to not believe in things that are true.

We can see and describe the same things subjectively. We can even measure these phenomena objectively and agree on the data. But our worldviews will lead us to different interpretations of what we experience and measure. For example, for thousands of years it was believed, incorrectly, that the visible planets moved in *perfect circles*. This error led to an unexplainable anomalous observation: at times some planets appeared to be moving backwards. "Mercury is in retrograde" is one example of how this would be described. All scientific observers saw this phenomenon and were puzzled by it.

In the early 1600s, Johannes Kepler discovered and proved that the planets *do not move in perfect circles*. Rather, their orbits are elliptical. Therefore, Mercury is never in retrograde. It only appears that way *if one assumes its orbit is a perfect circle*. Once it was known that its orbit is elliptical, the mystery was solved. And the scientific worldview changed.

The subjective observations of the planets did not change. The objective data did not change. But the worldview's *underlying assumption* changed and the *interpretation* changed. As a result, the scientific picture of reality became more accurate.

Our present-day worldview—not only in the West but in many cultures around the planet—can be described as a **mechanistic-metaphysical worldview**, characterized by such oppositional dichotomies as "Matter vs. Spirit, "Science vs. Religion," or "Body vs. Soul." It is through this "split" worldview that we interpret both our subjective experiences and objective data about these experiences. Today, new knowledge is emerging that fundamentally challenges the conscious and unconscious assumptions of this worldview and its major ways of knowing.

And each conference in our Cosmos and Consciousness series can also be characterized as a challenge to the conscious and unconscious assumptions of today's dominant worldview. Each conference has been an exploration of both new knowledge and new ways of knowing—neither mechanistic nor metaphysical--that could help us to understand the elusive underlying unity in nature. What is that underlying unity? To us, it is the enigmatic cosmic force called Love.

Today, Humanity is on the cosmic threshold—ready or not. As Wilhelm Reich wrote nearly 60 years ago, "We are in a process of deep and crucial change of our total existence, biological, physical, emotional and cosmic." There are no "experts" to whom we can turn for answers regarding questions about new knowledge at this turning point in our existence. Therefore, we must each become an expert in new knowledge.

We all have a lot of *unlearning* to do, a letting go of inadequate, sometimes beloved beliefs, along with *learning* new and sometimes difficult information. How can this be done? Is there nothing than can guide us along this challenging path? We think that extraordinary experiences offer valuable information and insights that have the potential to guide us forward.

Our Quantum Universe of Universes

Dr. Schild, an astrophysicist and cosmologist at the Harvard-Smithsonian Center for Astrophysics, is highly regarded professionally for his work on gravitational lensing, baryonic dark matter and the study of quasars and black holes. In recent years, he has observed structures in the universe that he and his team call MECOs (Magnetic Eternally Collapsing Objects). Dr. Schild is the author of over 200 articles published in peerreviewed professional publications. In addition, he is the Editor in Chief of the highly successful—and fascinating—online publication,

According to Dr. Schild, recent developments in brain research strongly support a new view of the overall architecture of the universe. And, unsurprisingly, it accommodates what has been known all along by everybody except university scientists. Dr. Schild will report on an experiment that demonstrates how the mind can affect the quantum/classical properties of a laser interferometer. He will examine the implications of this experiment for our understanding of the nature of information in the universe.

At a recent Prague conference on the foundations of quantum mechanics, Dr. Schild first heard of the nature of quantum states that are now known to interact with the brain. He will discuss the nature of dark energy and how it is processed by the MECO/black-hole structures that he has previously described at Cosmos and Consciousness conferences and in professional papers. Dr. Schild will present a new overall view of the nature of consciousness in our quantum Universe of Universes. This is a talk you won't want to miss!

Ms. Colasanti completed her post-graduate degree at Boston University School of Social Work's Advanced Standing Program. She completed her clinical internship at The Cambridge Hospital, Department of Psychiatry, Harvard Medical School. For eight years she was the Clinical Director for the Center for Psychology and Social Change, an affiliate of The Cambridge Hospital, Harvard Medical School. She has been a keynote speaker at many conferences and workshops.

For eight years, Ms. Colasanti worked with Harvard psychiatrist Dr. John E. Mack as Clinical Director of the Center for Psychology and Social Change. Through the Center's Program for Extraordinary Experience Research (PEER), they explored together the enigmatic phenomenon of human encounters with UFOs and extraterrestrial beings. Over 200 women and men participated in this effort, telling their stories in the hope of achieving a better understanding of what they had experienced and what it meant for them individually and for all of us as a society.

At PEER, Ms. Colasanti and Dr. Mack faced a fundamental challenge professionally. Their clinical experience told them that these reported experiences were true. But their worldviews told them such stories could not possibly be true. Join us for a first-hand account about what was learned in the course of the fascinating work at PEER--about the extraordinary experiences themselves; their impact on the women and men who had them; and the profound questions they present to our understanding of the nature of reality itself.
