President's Message

Dr. Robin Farley



This is my last update so I want to first thank you for the privilege and honor of serving as the Washington Chapter President for the last eleven months. I will continue to participate in Chapter events and look forward to supporting Leslie Ferguson as the new President.

This has been an exciting year for me. In addition to being Chapter President, I am celebrating my 30th year in the Washington Area. I came to work for the Navy Comptroller in the summer of 1989. Since then I have been all over the DoD Financial Management community including stints in Navy Budget, DoD Comptroller, DIA Chief Financial Executive, the private sector for five years at LMI, and then five years at Commander, Navy Installations Command. Four years ago I came back to where I started and took charge of the Navy's STARS to SABRS project, a financial migration of half of the Navy Commands from one GL to another one.

The STARS to SABRS project has been what I have been trying to do since starting in the government thirty years ago – lead an enterprise-level system and process transformation which materially changes how the Navy works. Many of us who have been around for a while recognize how unusual it is to land in a job in our “sweet spot,” that requires the special Knowledge, Skills, and Abilities (so-called KSAs) that we have acquired and honed over the years. It doesn't happen often, and when it does you have to take full advantage of the opportunity.

The one piece of parting advice that I will offer to the folks reading this is, get ready to contribute. Figure out what you are good at, hopefully something that you find both interesting and satisfying, and just do it. Passion and mastery even over something small is a powerful force which will always distinguish you from your peers. If you keep learning and keep asking the question “why?” so that you can come up with better ways of doing things, your career will take care of itself. I've been doing that for 30 years now, and I just received word this week that I've been approved by the Office of Personnel Management to serve as a permanent SES.

Hard work, imagination, and commitment to change really does pay off. Thanks and don't forget my favorite quote about financial managers in the Department of Defense; “the only thing that they hate more than change is the way things are.”

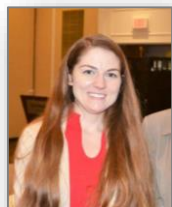

“Who Dares Wins, a Recap of the 2019 NCR PDI”

The NCR PDI 2019 occurred March 14, 2019 at the Roald Reagan Building and International Trade Center in Washington DC as it has in prior years and will be next year (March 11). The year’s theme: Who dares wins!

Before, during, and after the events I was sure to connect with colleagues of my past, present, and future with special mentions of my current organization affiliation and role. People are interested in AFCAA! The first come, first serve morning and afternoon sessions aligned well to this “Who dares wins!” theme with particular focus on risk and risk management.

Once the introductory activities were complete, we shifted into a spirited panel addressing “How the Audit & Reforms Drive Transformational Outcomes” with Honorable Thomas Harker, Honorable John Roth, and Honorable John Whitley. It is safe to say each Service’s financial management leader remembers the Defense Integrated Military Human Resources System well enough to recognize we should avoid that approach in the future. Hence the current, semi-service-silo approaches to ERPs and audit activities rather than boiling the ocean. They also shared independent responses to questions of the facilitator and audience members after touting their audit progress, robotics endeavors, and ERP efforts. Something I noticed Mr. Roth seemed most passionate about, with echoes from Honorable Harker and Honorable Whitley, was the battle of getting good people into government to build and sustain momentum. He touched on the struggles and frustrations we know well regarding timing, processing of actions, obstacles in hiring from so many rules, being competitive with industry, and being an attractive employer. If you hear about the video Mr. Mark Easton’s presentation started with, it was great – for laughs and reality...perhaps recruiting. - ***continued next page***

My breakout events and topics included Mr. Greg Little's CFO of the Future, Ms. Jane Roberts' A Critical FM Lever: Enterprise Risk Management, and the US Navy/US Marine's trio member panel providing a military service update. The first was a combined tutorial into DRCEDS alongside vignettes of the origination, brief history, recent uses, and attributes for future use. The second was an audience-interactive presentation with a lifelong practitioner in risk who gave a technical side to our luncheon keynote speaker's (Mr. Chip Fulghum, DHS Deputy Under Secretary for Management) generalized presentation: Disruption for Lasting Change. Mr. Fulghum's thoughts on taking risk were enlightening given his roles with DHS, tales (with congress, employees, GAO, IGs, etc.), and catchy sense of humor. The third event and topic related well to our supply situation as panel members talked to the astounding surprises in systems, inventory, savings, and the ways ahead.

Once the day closed, I joined a small group of government personnel for the Speed Mentoring Session providing additional CPEs to maximize the day's opportunities. My table enjoyed the graciousness and insights of Mr. Craig Bennett, Coast Guard; Ms. Kristyn Jones, KPMG; and Mr. Tom Steffens, US Army Corps of Engineers. Among the many take aways, Mr. Steffens providing an 7-item list of success tips, which many mirror the core values of the Air Force and Army: a) integrity (without it we have nothing and once it's lost it's hard to regain), b) dignity and respect (especially for diversity among people), c) have and uphold standards of performance for yourself and others, d) communication (e.g., mediums, verbal and written, ongoing), e) practice stewardship of peoples' time, f) develop and care for team (e.g., professional development, creating fun team building opportunities, give guidance, etc.), g) have fun!

For those who didn't attend, but wish to support the charitable organizations of choice, ASMC selected Pets for Vets and the Capital City Food Bank.

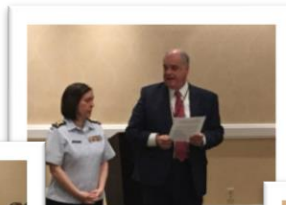

TOPIC: FY19 Air Force Budget Execution

Ms. Carolyn M. Gleason, a member of the Senior Executive Service, is responsible for planning and directing Air Force budget formulation and execution of appropriations totaling more than \$160 billion annually. Ms. Gleason leads a staff of civilian and military financial managers who develop, defend and execute funding that supports military operations and Air Force priorities at the direction of Congress, the Secretary of Defense and the Secretary of the Air Force.

Ms. Gleason discussed the challenges the Air Force is facing with FY19 Budget Execution, including the effects of Hurricane Michael, a massive 7.0 earthquake in Alaska, and flooding which crippled part of Offutt Air Force Base in Nebraska. At the conclusion of the luncheon, Ms. Gleason told the audience that she was leaving her current position as Associate Deputy Assistant Secretary (Budget), US Air Force, to become the new Assistant Deputy Under Secretary of the Air Force, Management and Assistant Deputy Chief Management Officer. We wish her all the best with her new position.

The SIG is charged with; administering the Commander's Accountability and Execution Review (CAER) program, fiscal stewardship leader education, and implementing the Finance and Comptroller Strategic Plan in support of the Army 2028 Vision and the National Defense Strategy.

COL LaSala was commissioned an Infantryman through ROTC at Norwich University. 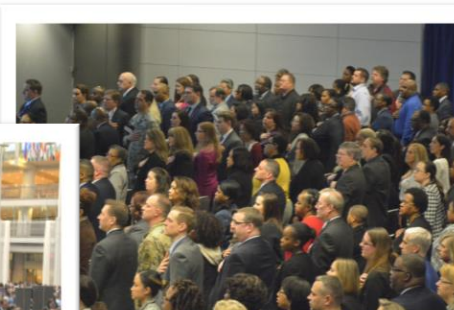

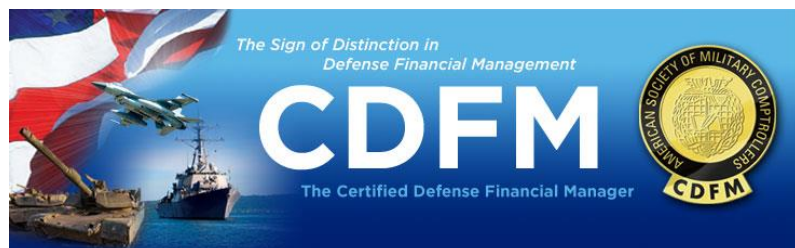

While most candidates in the CDFM program are civilian or military/reserve members of the Department of Defense, U.S. Coast Guard, U.S. Army, U.S. Air Force, U.S. Navy, U.S. Marine Corps or employees of defense contractors or suppliers, the CDFM program is open to all candidates who have a high school diploma (or equivalent) and meet the following work experience qualifications:

Have the required number of years of defense-related financial management experience outlined below:

- **Two (2) years if you hold an Associate's degree or higher;** or
- **Three (3) years if you do not have a degree.**

OR

Do not have defense-related financial management experience, but can meet the following criteria outlined below:

- **Four (4) years of Federal government-related financial management experience;** and
- **An Associate's degree or higher.**

There are three steps involved with earning your CDFM:

1. Enroll in the CDFM Program. Your enrollment is valid for two (2) years, during which time you must take, and successfully pass, the three CDFM module examinations.

2. Submit Your Verification of Financial Management Experience Form. This form, which must be signed by a supervisor who can verify your work experience, must be returned to ASMC after enrolling in the CDFM program. You do not have to submit this form prior to taking a CDFM examination, but it is required prior to the awarding of the CDFM designation.

3. Purchase and Schedule the CDFM Examinations. Be sure to carefully – and completely – read the criteria associated with each testing option for the CDFM examinations. Failure to do so can result in the purchase of the wrong CDFM examination and/or the inability to test at your preferred location
