**Dr. Jay Best** is an eminent thought leader and technology strategist and one of the leading experts in applications of peer to peer systems and blockchain technologies. After joining MIT as a senior research scientist and doing work in distributed systems, deep learning and high-performance computing, he has been driving innovation and advising on application of blockchain and other information technologies to provide real-world solutions. Dr. Best has been speaking and holding seminars for global firms on technology strategy and innovation and how to leverage blockchain technologies to maximize profits.



Jamie Burke, CEO, OutlierVentures, is one of Europe's foremost investors and thought-leaders in the blockchain space. He founded Europe's first blockchain venture builder & fund <u>Outlier Ventures</u>. He also runs <u>Blockchain Angels Europe</u> to help educate angels and early stage VCs and connects them with the best start-ups from across the World for deal-flow. This gives him a unique perspective on the blockchain ecosystem.



Pinar Emirdag, Managing Director at Hupomone Labs, has worked on a broad spectrum of innovative developments in financial services as a designer, founder, developer of products and businesses, a strategic investor on behalf of institutions and an operator responsible for servicing a large sophisticated group of clients. She is the managing director at Hupomone Labs and a founding member of the UK Digital Currency Association. She was also one of the founders of Mathmoneyf(x). Prior to this, Pinar was responsible for managing London Stock Exchange Group's Business Development; at ICAP, as a MD responsible for Business Development in Institutional Brokerage. She previously held a similar role at Liquidnet and prior to that was at Citigroup. Pinar started her business career at financial services management consultancy, Oliver Wyman. Pinar holds a Ph.D. and M.Sc. in Physics and a M. Sc. in Electrical Engineering from Brown University.



**Paul Gordon** is a former derivatives trader who first became interested in Bitcoin in 2011. In 2012 Paul founded Coinscrum, the first Bitcoin and Block Chain technology networking group in London, which has since grown to be the largest of its kind in the world with over 2300 members. In early 2014, Paul was instrumental in helping to establish the UK Digital Currency Association (UKDCA), a trade body that has already had success in helping to guide policy surrounding the nascent Digital Currency industry in the UK. Paul is also a cofounder at Quantave, which develops digital currency exchange connectivity and data solutions.



**Dr Garrick Hileman** is an economic historian at the Cambridge Centre for Alternative Finance and London School of Economics Centre for Macroeconomics. He was recently ranked as one of the 100 most influential economists in the UK and Ireland and he is regularly asked to share his research and perspective with the FT, BBC, CNBC, WSJ, Sky News, and other media. Garrick has been invited to present his research on monetary and financial innovation to government organisations, including central banks and war colleges, as well as private firms such as Visa, Black Rock, and UBS. Garrick has 20 years' private sector experience with both startups and established companies such as Visa, Lloyd's of London, Bank of America, The Home Depot, and Allianz. Garrick's technology experience includes co-founding a San Francisco-based tech incubator, IT strategy consulting for multinationals, and founding MacroDigest, which employs a proprietary algorithm to cluster trending economic analysis and perspective.
