# Working with Congress By: Office of the Secretary of Defense (OSD)

Congressional relations are an essential function in every Federal agency. It's how the Executive Branch works with the people's representatives in Congress, which is a separate and equal branch of government and the source of legislation, appropriations, and oversight.

As in the Armed Services, the Office of the Secretary of Defense (OSD) divides responsibility for working with Congress between two separate offices:

The Office of the Assistant Secretary of Defense for Legislative Affairs which deals with the authorizing committees, the Senate and House Armed Services Committees or SASC and HASC as they are commonly known, and other committees having oversight of national security, and
Budget and Appropriations Affairs (BAA) which is part of the OSD Comptroller organization. By law, BAA is responsible for working with the House and Senate appropriations committees -- the HAC and SAC – and their Defense subcommittees.

The liaison mission in OSD Comptroller is to serve as a conduit between Congress and the Department, explaining the President's Budget request and fostering bipartisan Congressional support for Defense program resources. They do this primarily by working with Committee staff members. It's challenging and rewarding work. Committee staffers are knowledgeable and dedicated. They are charged by Members of Congress to apply stringent oversight to budget requests and the execution of funds for Defense programs. The liaison's job requires knowledge of the programs in their portfolios and an understanding of committee views and those of staff members. With this background, they are able to help program managers and other stakeholders to better communicate the merits and requirements of the Defense organization on Capitol Hill.

In this back-and-forth, DoD financial managers can play an essential role. You may be called upon to provide a "response to query" for a Congressional office or committee, for example, or you may be asked to brief a staffer. In either case, there are some guidelines that will serve you well:

- Communicate with all Congressional stakeholders honestly, clearly, ethically, and in a nonpartisan manner.
- If briefing staff members, a prep-brief is a good idea. Consider the reason for the briefing and your objectives. Work out any disagreements, and identify weak areas in the presentation before the meeting.

- Employ accurate information. Thoroughly vet your response so that you have the latest thinking on an issue. Remember that the Department is large and decisions are made every day that could affect your program.
- Timeliness is also critical. Many times Congressional staffers are asking questions that need very quick response as they work on mark-ups, conferences, or floor action. There may be many others who will have views on a particular program or issue. So it's important that the Department's position is properly presented in time for decision makers to take it into account.

By following these guidelines, you can help us to earn and maintain Congressional trust for program execution. Delivering what we promise is what Congress expects.

Another key to a successful Congressional relations effort is to cultivate productive relationships. The liaison team's skill in this area will be called upon in the weeks and months ahead, as they adjust to changes on Capitol Hill caused by the recent election. With a Republican majority in the new Congress, Senate leadership has changed. Committees will be headed by new chairmen, and a full schedule of hearings is expected.

Key staff members are also changing roles. Some may be trading portfolios or even moving on. Liaisons will need to meet and brief the new staffers with responsibility for Defense financial issues. The liaisons' job is to ensure that DoD's voice is heard, especially on key issues.

That's important, because -- as they work to build new relationships – they may also need to deal with pressing issues that won't wait: The Fiscal Year (FY) 2015 budget is currently being executed. A budget for FY 2016 is due to be rolled out next month. The financial aspects of the U.S. response to ISIL in Iraq and Ebola in West Africa are on everyone's priorities list. And steady progress must continue in auditing the complex financial books of the Department of Defense. Congress is interested in all of these issues and more.

The Role of ASMC Professionals

In the effort to keep Congressmen and their staffs informed about the financial aspects of DoD, financial managers across the organization continue to have a vital role. You are the keepers of the data that liaisons depend on. When – in answer to questions -- you supply accurate, vetted information in a timely manner, you are helping to promote DoD's message on Capitol Hill and instilling confidence in our organization.

In short, it takes a team of Congressional liaisons and expert financial analysts to ensure that Congress understands the Department and its requirements. Working together, we help to make certain that the men and women of the Armed Forces have the resources they need to carry out their mission.

# National News

#### Carter confirmed as Secretary of Defense

Friday, February 13th, 2015

Yesterday, the Senate voted 93-5 to confirm Ashton Carter as the 25th Secretary of Defense. President Obama nominated Carter in December and the Senate Armed Services Committee cleared Carter's nomination earlier this week 26-0.

Carter succeeds Chuck Hagel who announced his resignation in November, but has continued in service until a new secretary is confirmed and installed.

Carter served as Deputy Secretary of Defense from December 2011 to December 2013. Prior to becoming Deputy Secretary, he was Under Secretary of Defense for Acquisition, Technology, and Logistics, a post he held from 2009 to 2011. Carter also served in the Clinton administration as Assistant Secretary of Defense for international Security Policy from 1993 until 1996.

During his Senate confirmation hearing (held February 4), Carter's nomination was generally applauded by members of the Senate Armed Services Committee (SASC). SASC chairman Sen. John McCain (R-AZ) called him "one of America's most respected and experienced defense professionals." Ranking SASC member Sen. Jack Reed (D-RI) said Carter was "uniquely qualified to lead the Department of Defense."

President Obama praised Carter's confirmation in a statement from the White House. "With his decades of experience, Ash will help keep our military strong as we continue the fight against terrorist networks, modernize our alliances, and invest in new capabilities to keep our armed forces prepared for long-term threats, Obama said.

Carter is expected to be sworn in next week.
