Treasurer's Report

The Treasurer stated that taxes were coming in late as expected. He estimates that three school districts had received into the office approximately half of the expected taxes to come in for the second half of the year.

No real estate taxes had been received by December 1st of the year so it was important that the investments were kept on a short term otherwise the December bond payments that are sizable, would have not been able to be paid. Fortunately, this was not the case through careful planning and coordination with our school district.

The Treasurers' Association was aware of this trend and were able to plan to forego some interest earnings and keeping investments short term. The Treasurer said he has been consulting with the school business managers to coordinate their school payments, as to leave the necessary cash flow which has been achieved to date.

The Treasurer said that SD #110 had their audit complete. School District #111 was still in process with the Reavis audit later than Burbank School District audit. Our audit was always the last and he anticipated it would be complete by the time the next board meeting occurred, and at the vey minimum our three school district audits would be completed. He said he was more concerned with the quality of the audit than the quickness of completion which many times was beyond the control of the Treasurer's Office.

Mr. Chisholm related his observations further regarding the real estate tax distributions.
